- In an effort to increase access to ICT services especially in the rural areas, the Malawi Communications Regulatory Authority (MACRA) through the Universal Service Fund (USF) identified resources to cater for the construction of purpose-built Model ICT Laboratories under the Connect a School Project.
- MACRA therefore intends to use part of the funds to procure Building Materials for the construction of up to 120 ICT laboratories under the **Second Phase** of the project across the country.
- The Chairperson, Internal Procurement and Disposal Committee (IPDC)**, now invites sealed bids from eligible Suppliers for the following categories of goods and services;
